Concerning the preparation works, we would like to inform you that the exhibition halls will be accessible from Thursday July 25<sup>th</sup> at 10 a.m. and that **the installation should be finished imperatively by Friday 20<sup>th</sup> at 16 p.m.**

After the Dog Show, the location has to be freed at the latest by Monday 29<sup>th</sup> at 4 p.m.

We invite you to send your reservation form at your earliest convenience.

As far as we are concerned, we won't fail to address you a confirmation of reservation to which we will join the safety and security regulation imposed by the authorities. **In particular, the presence of an extinguisher in every stand will notably be required.**
